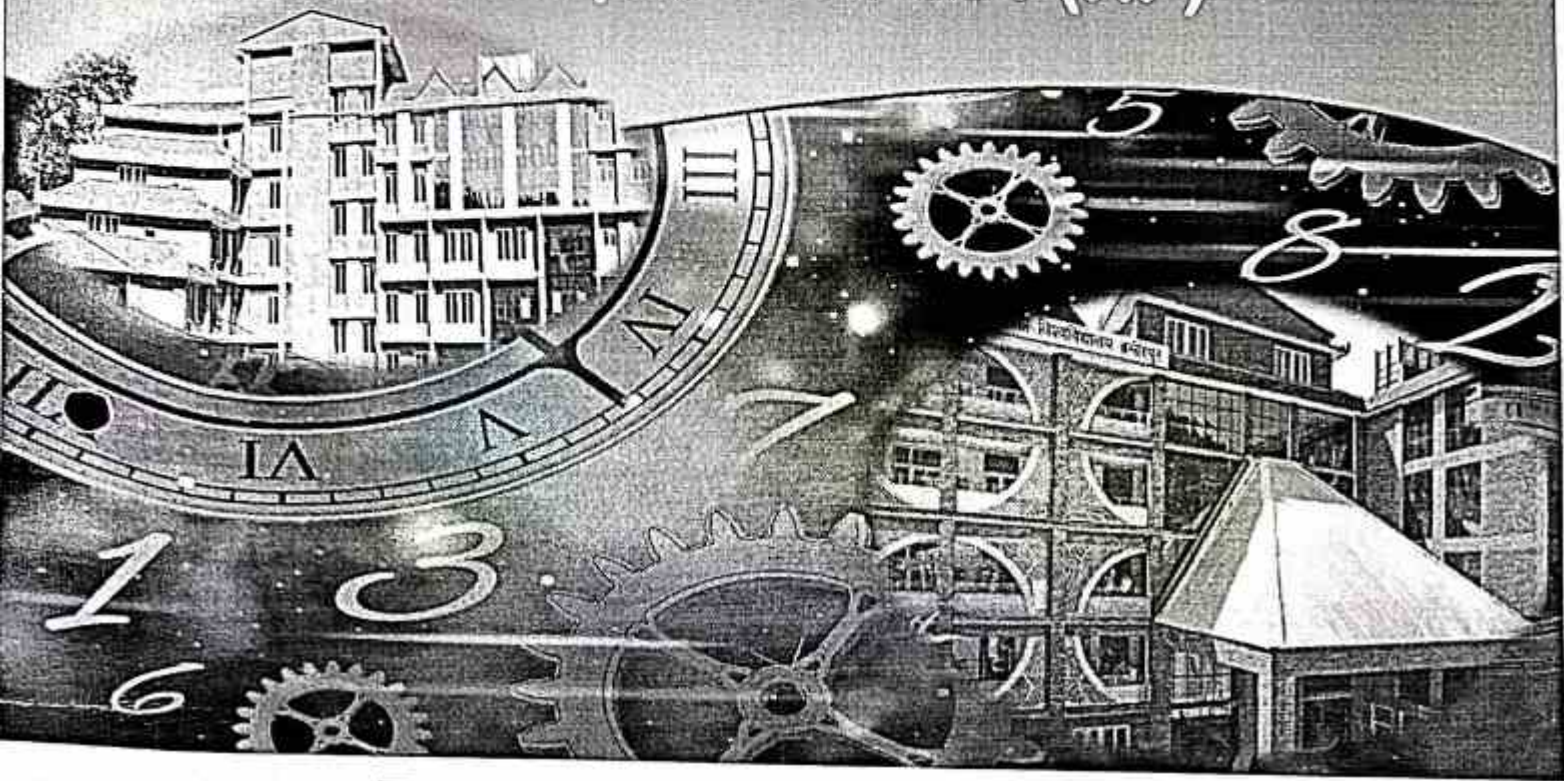

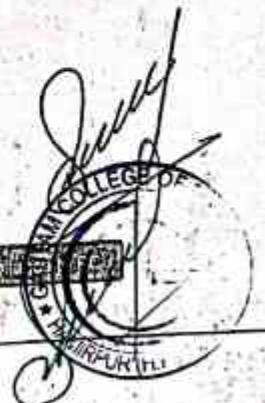

The affiliation is subject to fulfillment of the following deficiencies in the Institution/college pointed out by the Expert Visit Committee/Inspection Committee in their report/ recommendations.

- Faculty cadre ratio as per norms is required to be maintained.
- Institution is required to appoint more Senior Faculty and Non-Teaching Staff and Lab Technician as per AICTE/PCI norms.
- Institution is required to pay salary to the staff as per norms.
- Institution is required to procure more books as per curriculum requirement.
- Exhaust Fan required to be installed in all labs.
- More glasswares and Microscopes required.
- Fire safety equipment need to be installed.
- Machine room needs to be maintained properly.
- CIR needs to be operated with more equipments as per PCI norms.
- Institution is required to procure Journals and books as per PCI norms.
- Sports and Wi-fi/ internet facility should be available for students.
- Computer of latest configuration are to be procured. Printing facility to be provided in computer lab. Internet bandwidth of 100 mbps to be provided. Legal application softwares are to be procured.
- Sanitary facility is required to be provided in girls common room.
- Institution is required pay the salary to the staff as per norms of the Govt/PCI.
- Training & Placement cell required to be strengthened.
- Institution is required to ensure the registration of all the students and faculty on SWAYAM portal/MOOC courses as per the guidelines of AICTE.

- g) As per provision applicable in Himachal Pradesh Technical University, Ordinance No.61, Chapter -IV, Clause 9 (ix-x) and Schedule-V, the institution may, if so desires submit appeal for consideration by the Standing Appeal Committee within ten days from the date of issue of this letter.

Submission of compliance report is required in respect of above deficiencies along with documentary evidence within a period of two months from the date of issuance of this letter so that fresh affiliation letter may be issued.
