As we move forward to the second day of our conference, we are optimistic that it will be equally enriching and successful. Thank you.



## OUTCOME

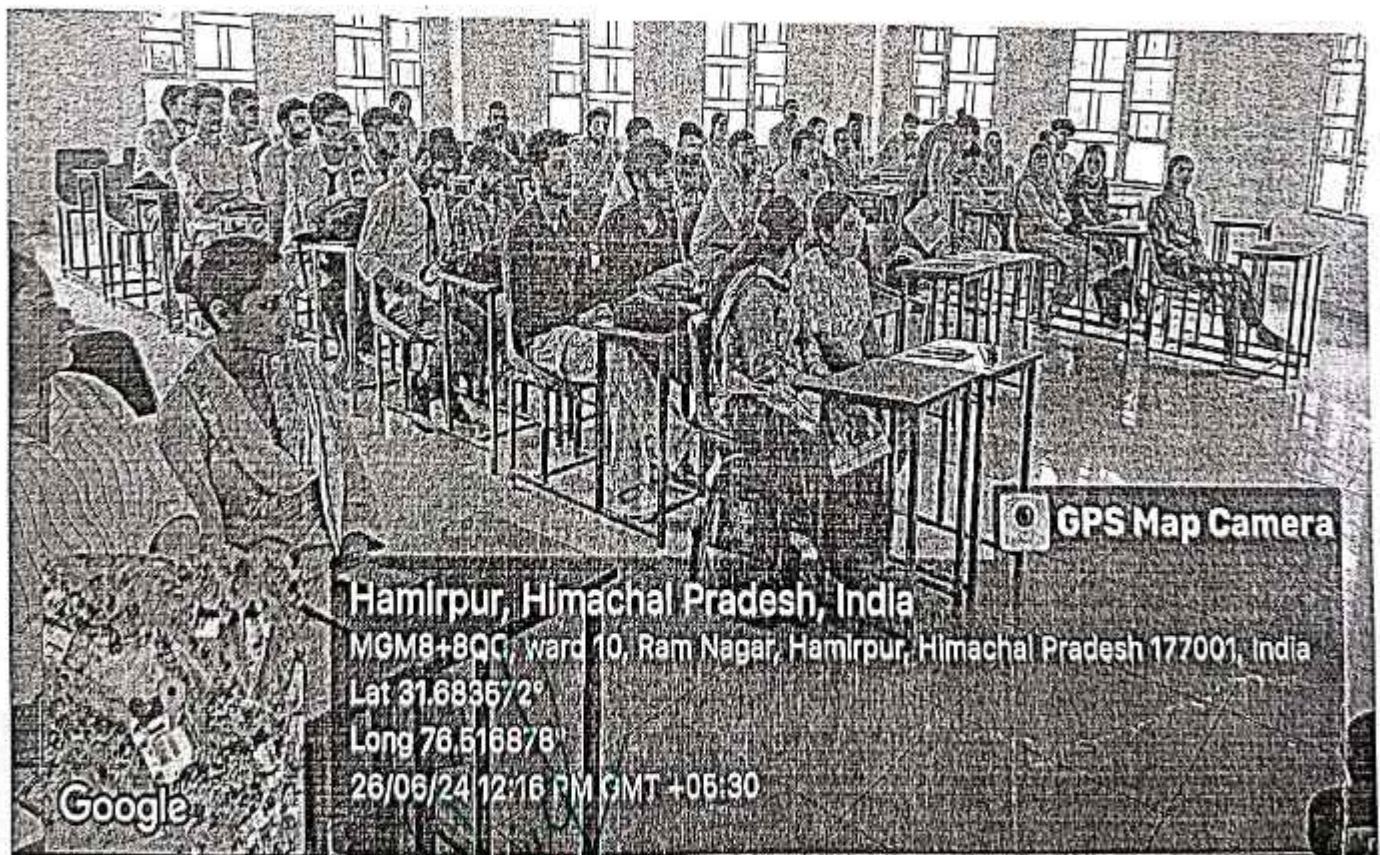
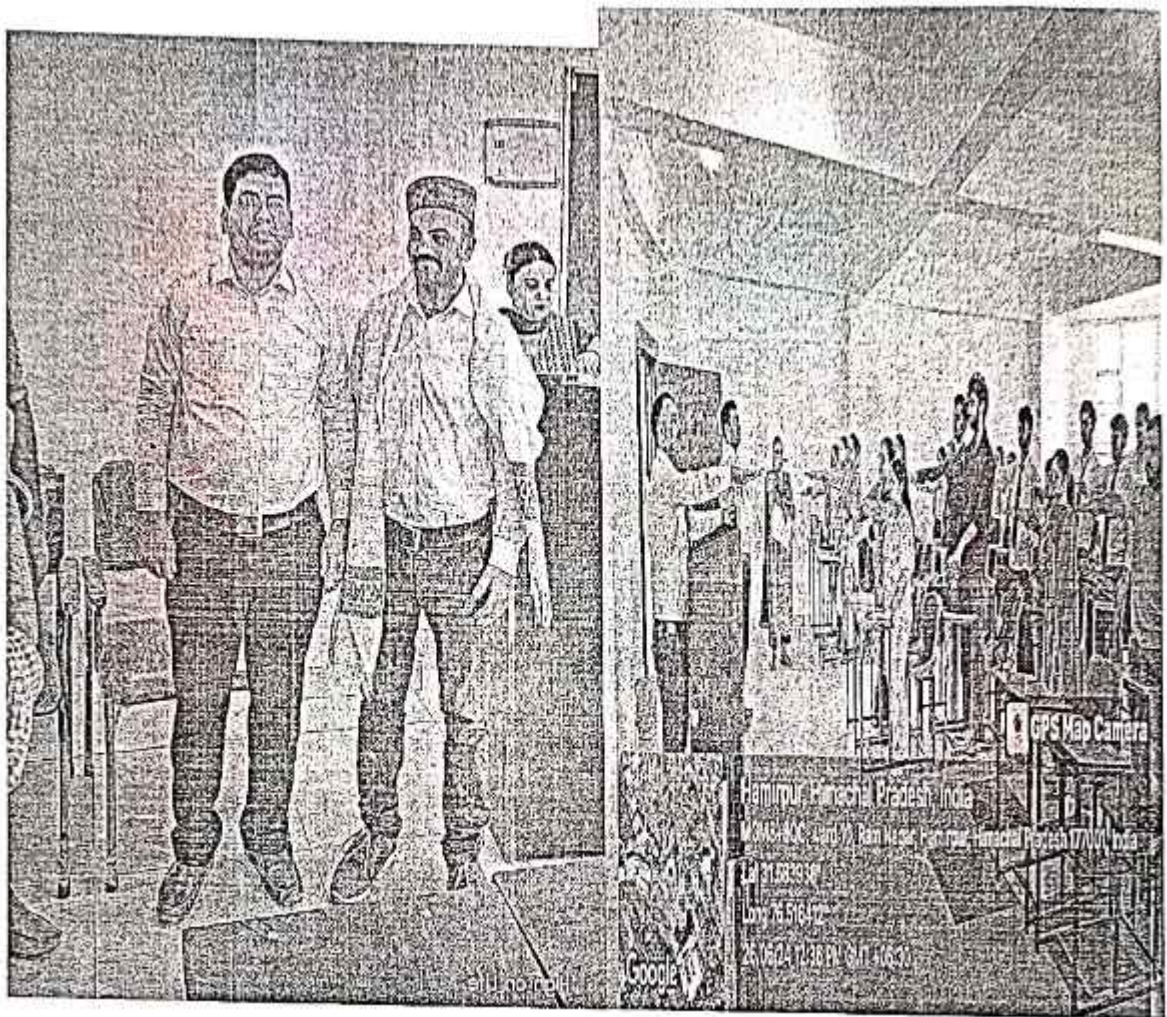
The event successfully met its objectives, with the following outcomes:

## NEXT STEPS


To build on the momentum generated by the event, the following steps are proposed:
